AMENDED AND RESTATED ARTICLES OF ORGANIZATION EMPIRE ENTERTAINMENT GROUP, LC

The undersigned member, pursuant to \$608.411 of the Florida Statutes, hereby amends and restates the Articles of Organization for Empire Entertainment Group, LC as follows:

Article I. Name

Article II. Duration
