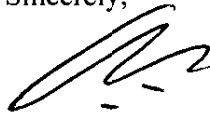

GARBER PROPERTIES, L.L.C. (SIESTA & JULIA)**

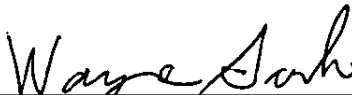

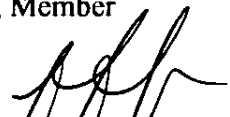
WHEREAS, the undersigned have executed this document for the purpose of expressing their unanimous intention and consent that the Articles be amended in the manner hereinafter set forth.

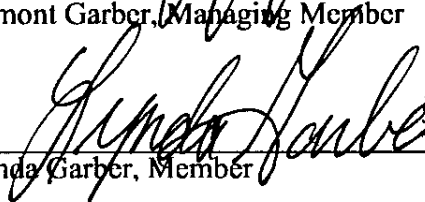
