The following have associated themselves for the purposes of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit:

The following Articles shall be the charter and authority for the conduct of business of such limited liability company.

##### **Members Rights To Continue Business**

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business upon unanimous consent of such remaining members provided, the consent is obtained within ninety (90) days of the occurrence of one of the above events. If the necessary consents of the members are not obtained, then the limited liability company shall be dissolved, liquidated and terminated pursuant to the Members' Operating Agreement.

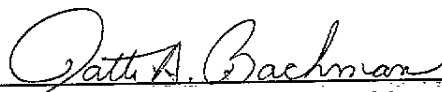
