**FIRST ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
REALUSE.COM INTERNET SERVICES, L.C.**

Pursuant to Section 605.411 of the Florida Limited Liability Company Act, RealUse.com Internet Services, L.C. adopts these Articles of Amendment:

FIRST: The name of the limited liability company is RealUse.com Internet Services, L.C.

SECOND: The limited liability company's Articles of Organization were filed with the Florida Department of State on March 5, 1999.

THIRD: Article V of the limited liability company's Articles of Organization is amended entirely to read as follows:

ARTICLE V. MANAGEMENT OF COMPANY


The business of the limited liability company will be managed by one or more managers who will be elected annually by the members of the limited liability company in the manner set forth in its Regulations.

The managers have the power and authority, to the exclusion of the members, to manage the affairs and business of the limited liability company and will hold the office and have the responsibilities that are conferred on them in the Regulations of the limited liability company. A member of the limited liability company does not have any authority to incur any contractual liability or obligation on behalf of the limited liability company, unless the member is a manager of the limited liability company.

FOURTH: The foregoing amendment of Article V was approved on November 23, 1999, by unanimous written consent of the sole manager and all the members of the limited liability company.

FIFTH: The foregoing amendment will be effective as of November 23, 1999 upon the filing of these Articles of Amendment with the Florida Department of State.
