Members of the Company have the right to admit new members on unanimous vote of all existing members.

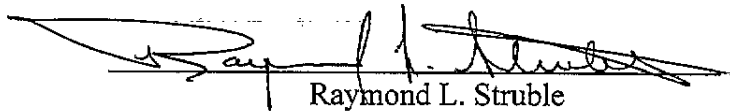
ARTICLE VII

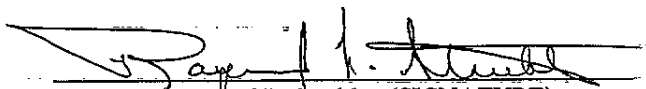
