## ARTICLES OF ORGANIZATION

### DALIKA INTERNATIONAL, L.C.

The undersigned, for the purpose of forming a limited liability company undersort the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 8 - ADMISSION OF NEW MEMBERS

All references in these Articles of Organization to "manager", "officer", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
