

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - Name:

The name of the Limited Liability Company is: LAKE MARY CENTER ASSOCIATES LLC

The retiring member shall have one year from the date of the retirement, etc to obtain a bonafide purchaser to purchase the entire interest of the retiring member. If the retiring member shall have received a bona fide arm's length written

offer, which is unconditional except as hereinafter provided (hereinafter called the "Bona Fide Offer"), for the purchase of such Interest the Seller shall give a notice in writing (hereinafter called "Option Notice") to the other Members and owner of Economic Interest (hereinafter called the "Remaining Members"), setting forth such desire to sell such Interest, which notice shall be accompanied by a photocopy of the original executed Bona Fid Offer and shall set forth at least the name and address of the Outside Party and the price and terms of such offer.

- (A) Within thirty days after the giving of the Option Notice, any or all of the Remaining Members may elect to purchase the entire interest of the Seller for which the Bona Fide Offer was made, at the same price and upon the same terms and conditions as contained in the Bona Fide Offer, in which event the Remaining Members shall be obligated to purchase and the Selling Member shall be obligated to sell such shares at the same price per share and upon the same terms and conditions as contained in the Bona Fide Offer. Each Member shall be required to purchase the Interest of the Seller in proportion to the Interest in the Company of each Remaining Member.
- (B) If any of the Remaining Members is unable to purchase his proportionate share of the Selling Member's interest then and in that event any other of the Remaining Members may purchase the share.
- (C) Failure of the Remaining Members to exercise their right of first refusal shall constitute a consent to the sale by the retiring member to the outside party and upon such failure the purchaser shall become a member without any further vote being required.

In the event of the death of a Member, a member may leave his entire interest or any portion thereof by testamentary devise to one or more distributees or devisee. - (b) To elect to retain the economic interest without any voting rights in which case the economic interest can be distributed to one or more distributees, in which case the Company shall be reconstituted among the Remaining Members.
