ARTICLES OF ORGANIZATION OF J. C. G. MANAGEMENT, L.C.

ARTICLE I

The name of this Limited Liability Company shall be: J. C. G. MANAGEMENT, L.C.

ARTICLE II

This Limited Liability Company shall have a perpetual existence.

ARTICLE III

This Limited Liability Company is created for the purpose of management of property (real and personal) and investments, marketing, business consultation and the acquisition of real property and in such other related business as may be agreed on by the members.

ARTICLE IV

ARTICLE V

ARTICLE VI
