**ARTICLES OF ORGANIZATION**

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, sets forth the following:

**ARTICLE I**

**NAME**

The name of the Limited Liability Company is JC AVIATION, LLC.

**ARTICLE II**

**PERIOD OF DURATION**

The period of duration of the Limited Liability Company shall commence upon the filing of these Articles in the office of the Secretary of State of Florida and shall terminate upon the first to occur of the following:

- (i) December 31, 2050; or
- (ii) Dissolution of the Limited Liability Company pursuant to provisions of the Florida Limited Liability Company Act.

**ARTICLE III**

**PURPOSE**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company, the business of the Limited Liability Company shall be continued unless the members elect otherwise.

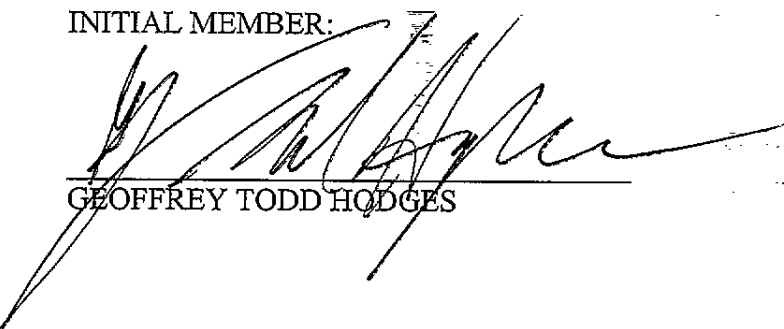
ARTICLE XI

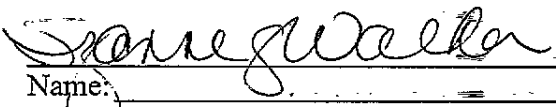
