

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I
Name

The name of the Limited Liability Company is: **RELIANCE CENTER, L.L.C.**

ARTICLE II
Address

ARTICLE III
Duration

Members' Rights to Continue Business

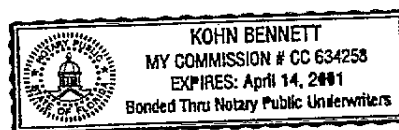


