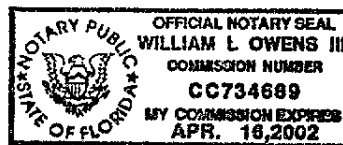

THIES PICKENPACK, being duly sworn, deposes and says that:

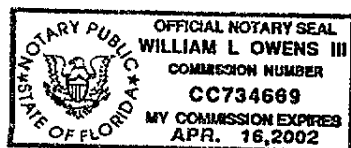
