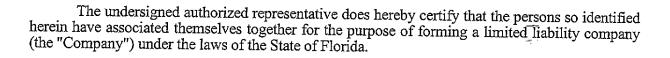

ARTICLE I NAME

The name of the Company shall be:

ARTICLE VI REGISTERED OFFICE AND REGISTERED AGENT

The street address of the Company's initial registered office in Florida is 101 E. Kennedy Boulevard, Suite 4100, Tampa, Florida 33602, and the name of its initial registered agent William Kalish. ARTICLE IX RESTRICTIONS ON MEMBERSHIP

Except as otherwise provided in the Regulations, no new members shall be admitted to the Company without the unanimous prior consent of the existing members. Contributions required of a new member shall be determined by the members as of the time of the admission of the new member to the Company. A member's interest in the Company may not be sold or otherwise transferred except with the unanimous consent of the members, or otherwise in accordance with the Company's Regulations. Additional restrictions and conditions on membership may be set forth in regulations adopted by the members.

ARTICLE X REGULATIONS

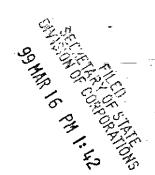
ARTICLE XI ACKNOWLEDGMENT
