ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE V – ADMISSION OF ADDITIONAL MEMBERS:

The right, if given, of the members to admit additional members and the terms and conditions of the admission shall be:

- (b) Persons wishing to become members in the future must be approved by a 3/4 vote of the founding members and/or their successors in interest.

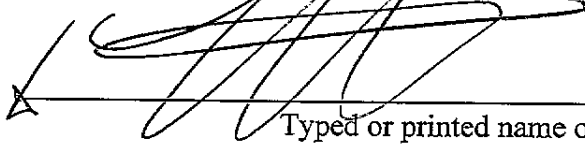

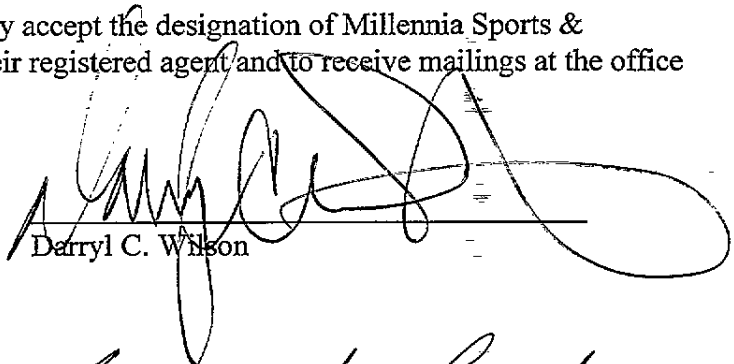

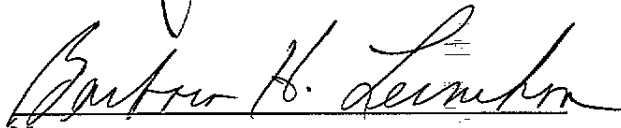
