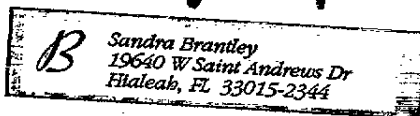

FIRST: The date of filing of the articles of organization was March 24, 1999.

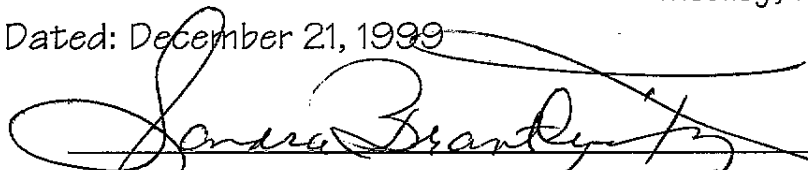
