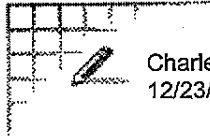

Hello,

I am starting my own small business as a Management Consultant. Although I am the only employee I attempted to file as a Limited Liability Company to avoid risk of personal liability as a Sole proprietorship. Letter number 398A00058072 for subject : C C ENTERPRISES LTD/LLC reference number W98000027497 was returned for correction stating that I needed additional documentation to file as an agent for a alien corporation. I called DOS Corporate Specialist, Diane Cushing, to explain the filing as an error. She was very helpful but also told me that the name chosen was already activated by someone else and that I could request a refund of fees to restart the process with a new name. I submitted check number 5408 for \$87.50 but the rejection letter stated you had only received \$43.75 so I don't know where the rest of the money went. However, I would appreciate your assistance to obtain a full refund of \$87.50 so that I may apply that toward the full incorporation fee of \$285.00.

I also submitted a request and fees to register a fictitious name. DOS Letter No. 698A0056962 notified me that C C ENTERPRISES LTD was approved with registration number G98334000129 and filed on November 30, 1998. If a corporation name does not require fictitious name to be filed I would also appreciate your help to cancel the registration and obtain a refund of \$80.00 filing fee. Thank you.
