The undersigned members of Ambassador North Apts., L.L.C., hereby execute and acknowledge these Articles of Organization for the purpose of forming a limited liability company (the Company) for profit in accordance with the laws of the State of Florida.

ARTICLE_

The name of the Company shall be AMBASSADOR NORTH APTS., L.L.C., and it shall have perpetual existence.

ARTICLE II

The general nature of the business of the Company is to engage in the transaction of any and all lawful business for which limited liability companies may be organized under Florida Statute 608.

ARTICLE III

Members of the Company may admit additional members from time to time, upon consent of two-thirds (2/3) of the members.

ARTICLE V

In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the remaining members may nevertheless continue the business of the company upon consent of two-thirds (2/3) of such members.

ARTICLE VI

The Company may be managed by a management committee consisting of at least one person or entity selected by at least two-thirds (2/3) of the members. Persons other than members may serve as managers. The initial manager who is to serve until the first annual meeting or until his successors are elected and qualify is:

The election of a manager or management committee shall be by consent of two-thirds (2/3) of the members and may include members as members of the management committee, as the members may determine from time to time.

ARTICLE VII

Members may assign or transfer the economic rights associated with their interest, but no other right of membership may be transferred without the consent of all other members. No assignee of any member's interest shall become a member without consent of all the other members, and the assignee's rights are limited solely to a creditor's remedies of a charging order against the assignor member's economic interest.

ARTICLE VIII

Distributions, profits and losses of the company are allocated proportionately with the member's respective contributions.

ARTICLE IX

The members may adopt regulations to govern the affairs of the Company by unanimous consent. The manager or management committee shall have no power to adopt, alter, amend or repeal regulations adopted by the members, other than emergency regulations in the event of a catastrophic event, as provided by Florida Statutes 608.423.
