Article VI - Members Right to Continue Business

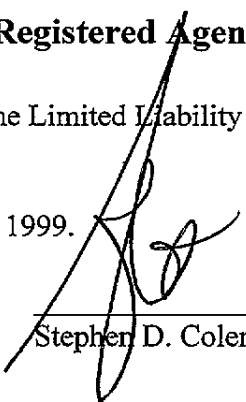

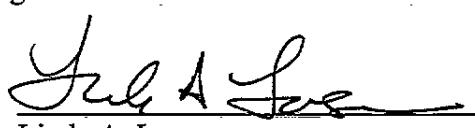

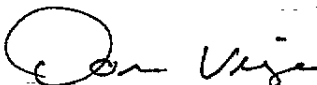
