ORDER

THIS ACTION came before the Court on April 17, 2008, upon Plaintiff's Motion for Entry of Amended Order Granting Keys Home Theater, Inc.'s Motion for Temporary Injunction.

IT IS ADJUDGED that a temporary injunction is entered against the Defendant, BENGHAZI, LLC d/b/a DOMINO'S PIZZA from filing Articles of Dissolution with the Florida Department of Corporations.

IT IS ADJUDGED that the Florida Department of Corporations shall revoke the Articles of Dissolution filed on August 7, 2006 by Defendant, BENGHAZI, LLC d/b/a DOMINO'S PIZZA.

IT IS ADJUDGED that the Florida Department of Corporations shall not require KEYS HOME THEATER, INC. to file an annual report on behalf of BENGHAZI, LLC d/b/a DOMINO'S PIZZA, as a prerequisite to maintaining BENGHAZI, LLC d/b/a DOMINO'S PIZZA active.

IT IS ADJUDGED that the Florida Department of Corporations shall maintain the Defendant, BENGHAZI, LLC d/b/a DOMINO'S PIZZA active during the pendency of this litigation, until further notice by the Court.

IT IS ADJUDGED that the bond is hereby set in the amount of \$ 10,000.⁰⁰
no surety required.
