**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
FOR LOS RIOS PROPERTIES, LLC,
a Florida Limited Liability company**

The following provisions of the Articles of Organization for LOS RIOS PROPERTIES, LLC, a Florida Limited Liability Company, with Articles of Organization having been filed April 5, 1999, under Document Number L99 000001890, and with there having been only one previous amendment, which was dated May 17, 1999, are hereby amended as follows:

ARTICLE IV is amended to read in its entirety as follows:

"The limited liability company is to be managed by three managers and the names and addresses of the persons who are to serve as managers are as follows:

Each manager shall have the full power and authority to act on behalf of the limited liability company and in its name. Each manager, acting alone, shall have the power to execute deeds, mortgages, notes and other instruments in the name of the limited liability company and thereby fully bind the limited liability company as fully as if all members and all managers had executed the instrument. Each manager, acting alone in the name of the limited liability company, shall have the power to sell and convey real and personal property owned by the limited liability company and receive and receipt for the proceeds, to incur indebtedness, sign promissory notes, mortgage property and otherwise act on behalf of and in the name of the limited liability company and bind it. No third party shall have the obligation to inquire of other managers or the members before accepting the act of one manager in the name of the limited liability company as the act of the limited liability company."
