These Articles of Organization of GREENLINE INVESTMENT GROUP, L.L.C., a Florida limited liability company (the "Company"), dated as of the 5th day of April, 1999, are being duly executed and filed by Randolph H. Fields, the organizer, authorized to form a limited liability Company under the Florida Limited Liability Company Act (Chapter 608 of Florida Statutes) (the "Florida Act").

- FIRST:** The name of the limited liability Company is Greenline Investment Group, L.L.C.
- SECOND:** The nature of the business to be transacted and the purposes to be promoted or carried out by the Company, is to engage in any lawful act or activity for which limited liability companies may be formed under the Florida Act, and by such statement all lawful acts and activities shall be within the purposes of the Company's business as permitted under the Florida Act.
- THIRD:** The Company is to be managed by managers (the "Managers") as appointed by the Members from time to time. - FOURTH:** The duration of the Company shall be perpetual, and shall begin on the date first set forth above, unless sooner dissolved in accordance with the Company's regulations and/or Florida law.
- FIFTH:** The principle address and mailing address of the Company is c/o 111 N. Orange Avenue, 20th Floor, Orlando, Florida 32801.
- SIXTH:** The Members of the Company may admit additional Members upon the requisite consent of the Members, in accordance with the Greenline Investment Group Limited Liability Company Operating Agreement (the "Operating Agreement").
- SEVENTH:** The remaining Members, if any, pursuant to the terms of the Operating Agreement or applicable law, may elect to continue the Company's business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company.

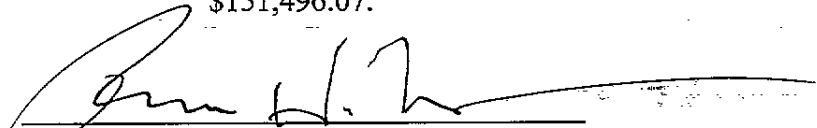

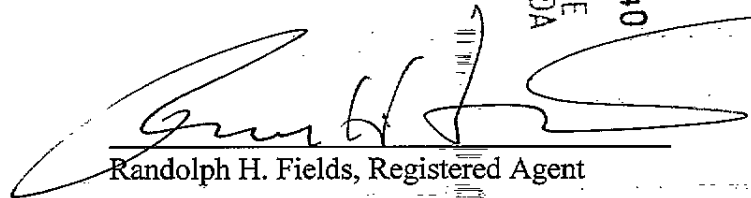
