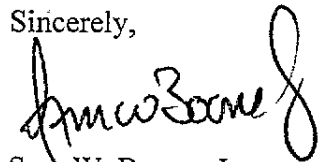

**ARTICLES OF ORGANIZATION
OF
EZ SOLUTIONS, LLC**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

EZ Solutions, LLC

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes Annotated Sections 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Florida is 6529 Millhopper Road, Gainesville, FL 32653, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Manu A. Patel.

FIFTH: The street address of the principal office and mailing address of the Limited Liability Company is 6529 Millhopper Road, Gainesville, FL 32653.

SIXTH: The Limited Liability Company is to be managed by the Managing Members. The names and addresses of the initial Managing Members are: Nagaraj Gangiah, having an address at 2124 Kitterage Street, #100, Berkeley, CA 94704, and Manu A. Patel, having an address at 6529 Millhopper Road, Gainesville, FL 32653

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Members is \$9,010.00. 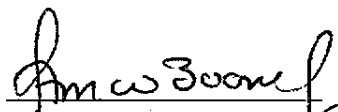

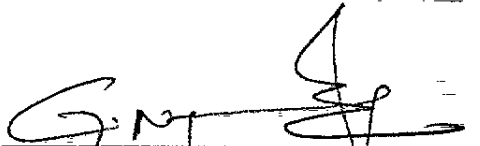
