## ARTICLES OF ORGANIZATION OF ONE MORE CHANCE, LLC

The undersigned, being the initial Member and Organizer of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.40 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

SECOND: The latest date on which the Limited Liability Company is to dissolve is 2050.
