**ARTICLES OF ORGANIZATION
OF
INLAND LAKE WALDEN G.P., L.L.C.**

ARTICLE I - Name

The name of the Limited Liability Company is INLAND LAKE WALDEN G.P., L.L.C. (the "Company").

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is: 2901 Butterfield Road, Oak Brook, Illinois 60523.

ARTICLE III - Duration

The Company shall exist perpetually, unless sooner dissolved in accordance with the Company's Regulations or Florida law.

ARTICLE IV - Management

The Company will be managed by its managing member (the "Manager").
