ARTICLES OF ORGANIZATION

OF

KEBAB KORNER I., LLC

ARTICLE I

Name

The name of the limited liability company ("Company") is KEBAB KORNER I., LLC.

ARTICLE II

Address

## ARTICLE VI

### Admission of Additional Members

Admission of Additional Members is subject to the following limitation: (i) the Members may admit to the Company additional Member(s) to participate in the profits, losses, available cash flow and ownership of the assets of the Company; (ii) admission of any such Additional Member(s) requires the written consent of all Members then holding a right to vote in the Company; and (iii) any Additional Members are allocated gain, loss, income or expense by the method provided in the Regulations.

## ARTICLE VII

### Death Retirement, Resignation, Expulsion, Bankruptcy or Dissolution of a Member

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, dissolves the Company unless all remaining Member(s) holding voting rights consent to the continuation of the business of the Company.

## ARTICLE VIII

### Affidavit of Membership and Contributions

The undersigned member or authorized representative of a member of KEBAB KORNER I., LLC. deposes and says:

(1) The above named limited liability company has at least one member.

(2) The total amount of cash contributed by members is \$2,337.50.
