**ARTICLES OF ORGANIZATION OF
AG-TURBINE TRANSITION, L.L.C.**

The undersigned, MARK J. WATSON, a natural person competent to contract, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I

The name of the limited liability company is:

AG-TURBINE TRANSITION, L.L.C.

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing address and street address of the principal office of the limited liability company is 6244 Pine Terrace Circle, Milton, FL 32570.

ARTICLE III - PURPOSES AND POWERS

This limited liability company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.

Members owning a majority in interest shall have the right to admit new members. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

ARTICLE IX - MEMBERS RIGHT TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members owning a majority in interest shall have the right to continue the business.

ARTICLE X - RESTRICTION ON MEMBERSHIP

A member's interest in the limited liability company may not be sold or otherwise transferred

except with written consent of the members owning a majority in interest.

ARTICLE XI - COMMENCEMENT OF EXISTENCE

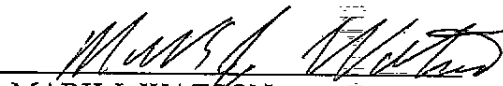
The date for commencement of this limited liability company's existence shall be the date these Articles are filed with the Secretary of State.
