CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

UNIVERSITY CLUB APARTMENTS OF TALLAHASSEE, L.L.C.

The undersigned, pursuant to the provisions of Chapter 608.411, Florida Statutes, files this Certificate of Amendment to the Articles of Organization of University Club Apartments of Tallahassee, L.L.C., a Florida Limited Liability Company, and states as follows:

- (1) The name of the Limited Liability Company is UNIVERSITY CLUB APARTMENTS OF TALLAHASSEE, L.L.C. (the "Company");
- (2) The date of filing of the Company's Articles of Organization is the 15th day of April, 1999.
 - (3) Item 3 of the Company's Articles of Organization is amended to state:
 - 3. <u>Purpose</u>. The Limited Liability Company shall be a single-purpose, single-asset entity. The sole purpose for which the Company is organized is to acquire, own, finance, develop, improve, maintain, lease, operate, manage, sell and otherwise invest in and deal with, a 26± acre tract of land located in Tallahassee, Leon County, Florida to be developed as University Club Apartments of Tallahassee. Said property shall constitute the Company's sole asset.
 - (4) Item 6 of the Company's Articles of Organization is amended to state:
- 6. <u>Capital Contributions</u>. The total amount of cash and a description and agreed value of property other than cash anticipated to be contributed to the Company is a maximum of \$1,357,500.00 in cash and real property having a fair market value of \$240,000.00.

(5) Except for the foregoing amendments, all other provisions of the Company's Articles of Organization shall remain unchanged and in full force and effect.
