**CERTIFICATE OF AMENDMENT  
TO ARTICLES OF ORGANIZATION

(1) The name of the Limited Liability Company is **UNIVERSITY CLUB APARTMENTS OF TALLAHASSEE, L.L.C. (the "Company")**;

(2) The date of filing of the Company's Articles of Organization is the 15th day of April, 1999.

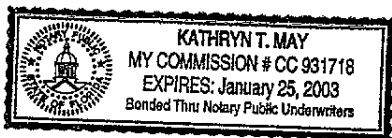


