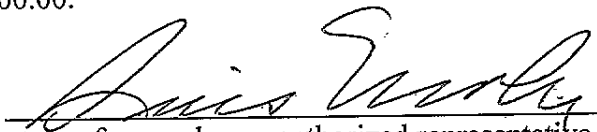
**ARTICLE VI**

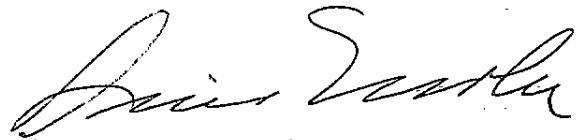

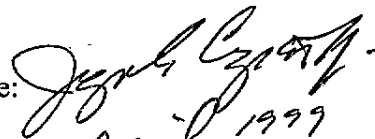
