ARTICLE I
NAME

The name of the Limited Liability Company is ALPHA FX, L.C.

ARTICLE II
ADDRESS

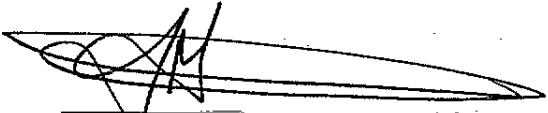
