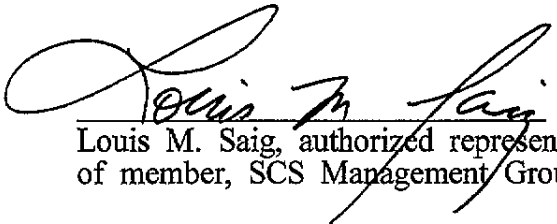
1. Name. The name of the limited liability company is Ocala Wings, LLC.

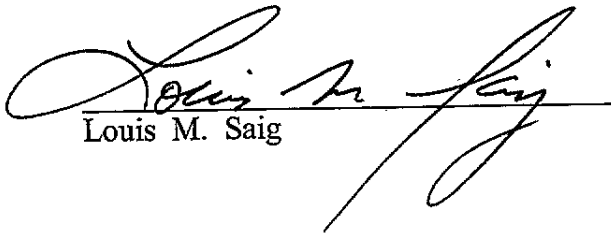
