# ARTICLES OF ORGANIZATION OF ROD & REEL MARINA & DRY STORAGE, L.L.C.,

a Florida limited liability company

JAMES S. MARAN, a natural person competent to contract, presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

#### ARTICLE I - NAME

The name of this limited liability company is:

ROD & REEL MARINA & DRY STORAGE, L.L.C., a Fiorida Umited liability company

This limited liability company is referred to in these articles as "the Company,"

#### ARTICLE II - PRINCIPAL OFFICE ADDRESS

#### ARTICLE III - PURPOSES AND POWERS
