The undersigned adopts the following Articles of Organization for the purpose of becoming a Limited Liability Company under the Florida Limited Liability Company Act.

1. Name. The name of the limited liability company referred to in these Articles as "Company," is:

THE GRAILCOAT COMPANY, L.C.

2. Duration. The Company shall dissolve on December 31, 2020.

3. Purpose. The business purposes of the Company are to develop, promote, market, sell and otherwise deal with a product utilized in the construction industry, known as "GRAILCOAT"; and to engage in any other lawful act or activity which may be carried on by a limited liability company under Florida law.

4. Addresses. The mailing address and the street address of the principal office of the Company shall be:

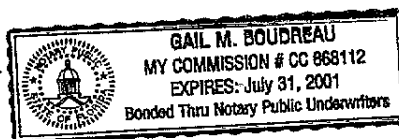

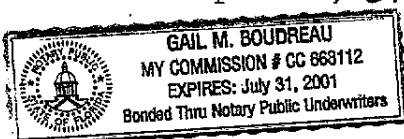
