

ARTICLES OF ORGANIZATION

OF

THE GRAILCOAT COMPANY, L.C. (A Florida Limited Liability Company)



The undersigned adopts the following Articles of Organization for the purpose of becoming a Limited Liability Company under the Florida Limited Liability Company Act.

1. <u>Name</u>. The name of the limited liability company referred to in these Articles as "Company," is:




