ARTICLES OF ORGANIZATION SCOTMAR, L.L.C.

The undersigned, desiring to form a Limited Liability Company under and pursuant to Chapter 608, Florida Statutes, entitled the Florida Limited Liability Company Act (the Act") does hereby adopt the following Articles of Organization for such Company:

- 1. Name. The name of this limited liability company is Scotmar, L.C. (the "Company").
- 2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of (i) thirty (30) years from the date of filing or (ii) the occurrence of any of the events specified in Florida of Statutes Section 608.441, unless continued by the unanimous consent of all the remaining members.
- 3. Purpose. - 10. Regulations and Operating Agreement. At the time of executing these Articles of Organization, the member of the Company shall adopt an operating Agreement containing all provisions for the regulation and management of this Company not inconsistent with law or these articles. The power to alter, amend or repeal the Operating Agreement shall be vested in the member of this Company (or, subsequently, members, as the case may be, if decided by majority vote). The members of the Company is more than one also may adopt a members agreement containing mutually accepted guidelines regarding the administration and governance of the Company.
- 11. Date of Existence of the Company. The existence of the Company shall commence on the date of filing of the Articles of Organization with the Florida Department of State.
- 12. Transfer of Interest. No member shall have the right to transfer any interest in the Company by majority vote of the members.
- 13. Certificated Interests. The members' interests in the Company may be evidenced by certificates.
- 14. Amendments. These articles, except with respect to the vested rights of the members, may be amended from time to time by a majority in interest of the members of the Company. All members of the Company agree to abide by the majority decision and agree to sign the certificate of amendment corresponding to such amendments for the purpose of filing with the Florida Department of State, consistent with the Act.
