### ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Floridat imited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE I -- NAME

The name of the limited liability company shall be Birding.com, L.L.C. ("Company").

### ARTICLE II -- ADDRESS
