SECOND: The Articles were filed with the Florida Department of State on April 26, 1999, and assigned Document Number L99000002357.


THIRD: Article I of the Articles previously provided as follows:

"The name of the limited liability company shall be WithoutBricks.com, LLC ("Company")."


