## **ARTICLES OF ORGANIZATION**

### **BAYWAY DOTHAN, LLC**

#### **ARTICLE I**

##### **Name**

The name of the limited liability company is Bayway Dothan, LLC (the "Company").

#### **ARTICLE II**




