# AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF CIRCO GROUP, L.L.C.

CIRCO GROUP, L.L.C., a Florida limited liability company organized pursuant to the Florida Limited Liability Company Act, § 608.401 *et seq.*, on April 28, 1999, sets forth the following as its Amended and Restated Articles of Organization, which shall supersede its original Articles of Organization:

## ARTICLE 1. Name

The name of this limited liability company is CIRCO GROUP, L.L.C. (the "Company").

## ARTICLE 2. Purpose
