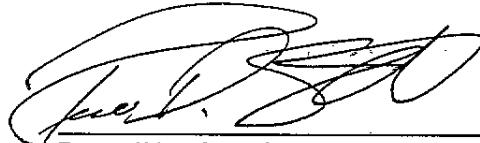

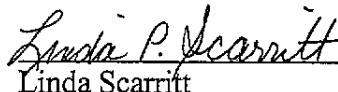
Other Provisions

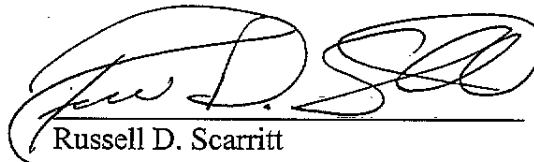

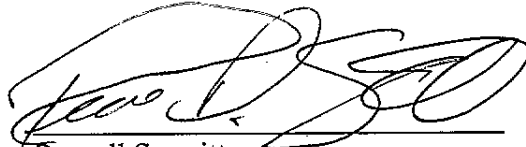

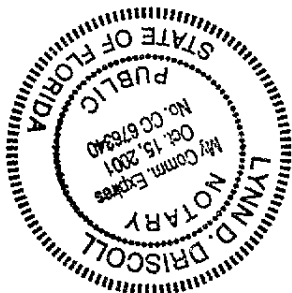
