ARTICLES OF ORGANIZATION

OF

ADMIRALTY CAPITAL, LLC

Article 1. Name

The name of the Limited Liability Company is:

Admiralty Capital, LLC

Article 2. Duration

The duration of the Limited Liability Company is perpetual.

Article 3. Principal Office and Mailing Address

The principal place of business of the Limited Liability Company is at Pelican Bay Financial Center, 8889 Pelican Bay Boulevard, Suite 201, Naples, Florida 34108. Article 6. Admission of New Members

The sole Member may elect to admit additional members upon the affirmative consent of the sole Member.

Article 7. Right to Continue Business

Upon the retirement, resignation, expulsion, bankruptcy, or dissolution of the sole Member or the occurrence of any other event which terminates the continued membership of the sole Member in the Limited Liability Company, the sole Member's successor-in-interest may elect to continue the business upon the affirmative consent of the sole Member's successor-in-interest.

Article 8. Statement of Management

Article 10. Regulations

These Articles of Organization and the Florida Limited Liability Company Act shall be deemed to be the regulations of the Limited Liability Company unless and until the sole Member otherwise adopts additional or inconsistent provisions in connection with any matters permitted to be addressed in regulations.

Article 11. Amendment

The sole Member reserves the right to amend or repeal any provisions contained in these Articles of Organization or any amendment to them in accordance with the regulations of the Limited Liability Company, and any right conferred upon the sole Member is subject to this reservation.
