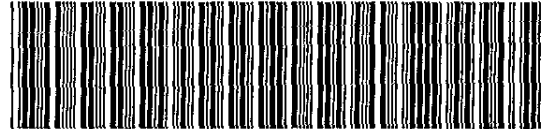

**SECOND:** The following amendment to the articles of organization was adopted by the Florida limited liability company:

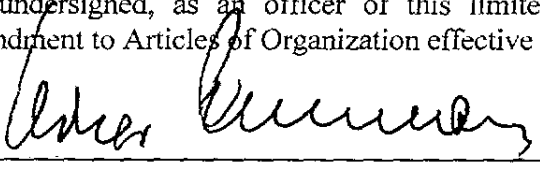
RESOLVED, that Article I of the Articles of Organization be, and the same hereby is, deleted in its entirety and the following be, and hereby is adopted in substitution therefore:
