may be admitted upon a majority vote of the Class A members. Any other new members may be admitted only with the written approval of all members.

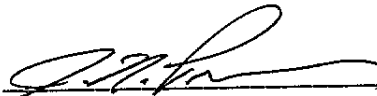
ARTICLE VI - Members Rights to Continue Business:

ARTICLE VII - Initial Registered Office and Registered Agent

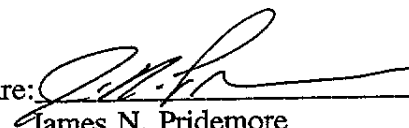
