CERTIFICATE OF AMENDMENT TO
THE ARTICLES OF ORGANIZATION
OF CENTRAL FLORIDA DIGITAL XPRESSION, L.L.C.

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida limited liability company hereby adopts the following Certificate of Amendment to its Articles of Organization:

Article I - Name and Date of Filing

The name of the corporation is CENTRAL FLORIDA DIGITAL XPRESSION, L.L.C. (hereinafter referred to as the "Company"). The Articles of Organization for the Company were filed on May 12, 1999.

Article II - Adoption and Text of Amendments
