**ARTICLES OF ORGANIZATION OF
INLET BEACH—ONE, L.C.**

ARTICLE I

Name

The name of the limited liability company ("Company") is INLET BEACH—ONE, L.C.

ARTICLE II

Address

The business may be continued only on the unanimous written consent of the remaining members.


ARTICLE VIII

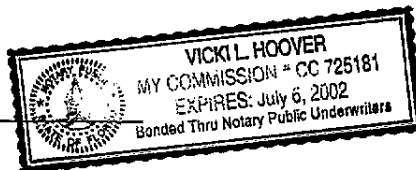


**CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/
