Article IV of the Articles of Organization of GEMSTONE PROPERTIES, L.L.C. is to be amended, to replace the text of Article IV, which currently reads

There shall be three classes of membership interest in the Company, designated as Class A, Class B, and Class C interests. All membership interests shall be issued in units. There are 30 units of Class A interests and 9970 units of Class B interests. Each unit of Class A and Class B ownership shall have one vote on all matters on which such ownership interest is entitled to vote, either as a member or manager. The only difference between the classes of ownership interests shall be that Class A interests shall have voting rights and Class B interests shall have no voting rights, except as expressly provided in the Articles of Regulations of the Company. Voting on matters which both classes are entitled to vote shall be by vote of the membership interests as a whole and not by class.

There shall be 50 units of Class C membership interests, which shall have no voting rights. Class C interests shall receive priority distribution rights as defined in the Regulations.

and replace said text, with the following text:

There shall be one class of membership interest in the Company. All membership interests shall be issued in units. There shall be 10,000 units created. Each Member shall be entitled to cast one vote for each unit of membership he/she/it maintains, and in such case vote in proportion to the percentage of the Company owned. Upon the Transfer of an economic interest separate and apart from a Membership Interest, all voting rights that were previously appurtenant to such Interest shall terminate, and said transferee shall have no voting rights, but only the right to receive the economic benefits of ownership of said units.
