INITIAL REGISTERED OFFICE AND AGENT**

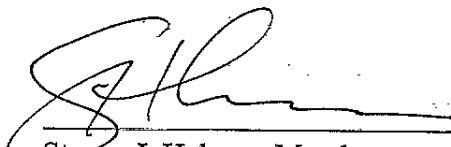

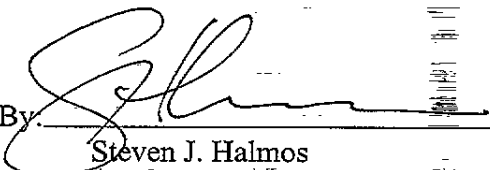
