ARTICLES OF ORGANIZATION
OF
LIMITED LIABILITY COMPANY OF

The undersigned, for the purpose of forming a Limited Liability Company under Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
NAME
