## <u>ARTICLES OF ORGANIZATION OF</u>

#### MERCURY SOUTH BEACH, LLC

The undersigned, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, does hereby establish the following:

- 1. Name. The name of the limited liability company is MERCURY SOUTH BEACH, LLC.
