ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608 hereby makes, acknowledges, and files the following Articles of Organization.

<u>ARTICLE 1 - NAME</u>
