ARTICLES OF ORGANIZATION
OF
LEONARD & LOWE, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be LEONARD & LOWE, L.C. (hereinafter referred to as "Company").

ARTICLE II -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

ARTICLE III -- ADDRESS

The mailing address and street address of the principal office of the company shall be 1680 SW Bayshore Boulevard, Suite 233, Port St. Lucie, Florida, 34984.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- ADMISSION OF NEW MEMBERS

The remaining members of the company shall have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the company, provided all remaining members consent to the continuation of said business.

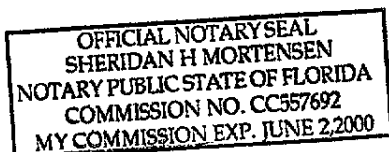

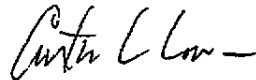
